Directions:

Take I-15 exit #292 for 11400 South, drive west 2.6 miles until you reach the entrance to the Bastian Agricultural Center. The FastCAT running area is on the east side of the polo field. Please use the free day parking available to exhibitors, there is no FastCAT parking on the polo field.

Important Times:

Each day's two tests will be run concurrently. Inspections will begin at approximately 9:30 am each day, with runs beginning at 10:00 am. Any exhibitors who are willing to commit to volunteering during the tests will be given preferred placement in the running order.

Exhibitors entering multiple dogs will need at least one handler for every 3 dogs. A handler may not bring more than 2 dogs to the starting line at one time.

Note: Dogs that are overweight and/or out of condition may be at risk for injury and exhaustion. Bitches in season are not allowed near the test area during the hours of the trial. The Inspection Committee has the authority to disallow a dog's entry into a test, and in such instances, applicable entry fees will be refunded.

Eligibility:

Fast Coursing Ability Tests (FastCAT) are open to all dogs at least 12 months of age on the day of the test that are individually registered with the AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program. (Go to www.akc.org/register/information/canine-partners to register your canine companion). Dogs with breed disqualifications and spayed/neutered dogs ARE eligible to enter. A dog may enter only once per test.

Tests Offered:

AKC FastCAT – The purpose of the AKC FastCAT® event is to provide all dogs and their owners an enjoyable, healthy activity in which they can participate. Dogs run individually. The dog's time to complete the 100 yard dash is converted into MPH. Dogs earn points based on their handicapped speed. Titles are awarded when a dog has accumulated a given number of points.

Any dog that displays aggressive behavior during trial hours will be excused for the day without refund.

Ribbon:

A light blue participation ribbon will be awarded for successful completion of the 100 yard run (dog must cross the finish line). New Title rosettes sponsored by USRCC will be available for all entrants who complete a title during the weekend.

General Information:

Battery powered machine and white plastic lure will be used. Backup equipment will be available. Time will be recorded using a laser timing system, with backup hand-timed stopwatches. **One dog handler is needed at both the start and finish line.** AKC rules no longer allow handlers to run in the lane if the dog does not run. Please be sure your dog can be safely and quickly retrieved at the end of the test. The field will be fully fenced.

A penalty of \$5.00 will be assessed for any loose dog not competing while the FastCAT is in progress.

All participants are expected to clean up after their dogs. No exceptions! USRCC provides waste bags and dedicated receptacles for exhibitors. There will be a \$5.00 fine for not cleaning up after your dog!

USRCC expects all participants to adhere to the AKC Code of Sportsmanship at all times. Concerns or disputes may be brought to the Test Chairman for resolution.

USRCC and Bastian Agricultural Center assumes no liability for injury to any person or dog before, during, or after the Test, including practice runs.
